U.S.-Made Bikes Bring Record Prices; Unit Numbers Slide

WASHINGTON, D.C.—U.S.-made adult bicycles and frame-fork exports set new records for average freight-on-board values in 2006, and small-wheeled bikes were within a few dollars of the record that category set a few years ago.

Adult-sized bikes—with wheel sizes larger than 25 inches—brought an average price of \$773, a 27 percent increase over 2005's record of \$606.

Exporters did not fare as well in unit

numbers. The full-sized bike category was off by nearly a third after enjoying a whopping 72 percent increase the year before. Small-wheeled bike exports were down 7 percent, but that was offset by an 8 percent increase in total value and an average FOB price of \$191, off of 2002's record of \$198 but well ahead of 2005's \$165.

Frame-fork combos' declared value was an average of \$63.41 per kilogram, a nearly \$20 increase over the average

\$43.67 set in 2005. Total value was up 12 percent, to \$57 million, but the unit numbers were down 23 percent.

U.S. exports gain substantive help from bikes that suppliers import from elsewhere, primarily China and Taiwan, and re-export globally. U.S. brands exported 51,500 foreign-made, full-sized bikes last year, up from 47,000 in 2005. The bikes' total value was \$15.24 million and average value was \$296. Exporters re-shipped 13,500 small-wheeled bikes,

down from 16,000 in '05, with a total value of \$1.92 million and average value of \$142, up from \$113 in 2005.

In total, U.S. bike exports yielded about \$71.72 million, and frame-fork sales brought about \$59.25, for a total of nearly \$131 million.

The figures do not include the substantial number of bikes and frames that U.S. brands have made in Taiwan, China or elsewhere and ship directly to Europe and other destinations. **BRAIN**
